## 1. Information We Collect

When you use our app, we may collect the following information:

### a) Account Information

When creating a user profile, we may collect:

- Biography or profile details you choose to provide

### b) Usage Information

We may automatically collect:

- Device type and operating system
- App version
- IP address
- Language settings
- In-app activity and interactions
- Crash reports and analytics data

### c) User Content

Any content you upload, post, or share through the app, including:

- Photos
  - Comments
  - Messages
  - Profile information

## 2. How We Use Your Information

We use your information to:

- Create and manage user accounts
- Provide and improve app functionality
- Personalize user experience
- Enable social and profile features
- Provide customer support
- Detect fraud, abuse, or security issues
- Comply with legal obligations

We only process personal data when we have a lawful basis under GDPR, including:

- Your consent
  - Performance of a contract
  - Legitimate interests
  - Legal compliance

## 3. Data Sharing

We do not sell your personal data.

We may share information with:

- Service providers that help operate the app
- Analytics providers
- Cloud hosting providers
- Legal authorities when required by law

All third parties are required to protect your data and process it lawfully.

## 4. Data Retention

We retain your personal data only for as long as necessary to:

- Provide the service
- Fulfill legal obligations
- Resolve disputes
- Enforce agreements

You may request deletion of your account and associated data at any time.

## 5. Third-Party Services

Our app may use third-party services to support functionality, analytics, hosting, authentication, customer support, and performance monitoring.

These third-party providers may process personal data on our behalf and are required to comply with applicable data protection laws, including GDPR.

Third-party services may include:

These providers may collect information such as:
